  - Must be signed by all Board of Directors for IRS purposes annually / not for profit status
  - o Recommendation to review the document and return to the next meeting signed
- Budgets and Cash Reserves
  - Discussions around ensuring that ISSA has funds to cover leases and other obligations (auditing purposes ~1-1.5 years of cash reserves);
  - Cash reserves of \$150,000 to \$200,000 per year (potential target)
  - Discussions around donations and grants to ISSA
  - Operating Plan and Budget
  - Financial Target around Cash Reserves
  - Striking right balance around financial stability, reserves and "giving back" to the clubs/players (i.e. Illinois State Cup Tournament)

- By-Laws "Rumors"

  - Claudio assured all new board members that 30 days prior to 2014 AGM the revised By-Laws were sent to all affiliate members for review and approval, then AGM was started – all documented in the 2014 Annual General Meeting Minutes – cleared with USASA
  - By-Laws were re-written as a stipulation for USASA loan (approved @2014 AGM; no changes)
